



Payment Options

Holy Family offers families a number of options for paying their fees.

The school's preferred method is Direct Debit and families can arrange a direct debit authority form from the front office or from our website (click on Parent Resources).

Families are able to make VISA, Mastercard and Cash payments at the front office. We can also arrange deductions through Centrelink.

The Community Portal can be used to view your current balance, recent statement and make payments. The statement provides full details and reference code of your account for payment.

Annual School Fees

The annual school fee covers the Tuition and Resources, Stationery, Ambulance Cover and School Insurance.

Early Payment Discount

If the total account fee is paid by 27th February 2026 a 10% discount will be applied on the total current year fees.

Sibling Discount

A sibling discount of 30% has been applied to the tuition fee for a second child, 40% for third and heavily discounted for the fourth and subsequent children attending Holy Family.



Invoicing/School Fees Payable

School fees will be invoiced annually. Fees are due and payable each term and your account should be finalised by 04/12/2026.

It is the legal responsibility of the signatories on the Enrolment Form/Acceptance of Offer to pay all school fees.

Where possible, parents are asked to make their own arrangements regarding payment of accounts if they live at separate addresses.

Parents can see their balance and statement via the Community Portal.

Health Care/Pensioner/School Concession Card Level

This level is only for families who hold a current means-tested concession card or are eligible for School Card Level.

** School Card applications will be available December from our office or complete online via www.sa.gov.au website.

Absence Due To Holidays

Fees will not be reduced for a student on holidays during a school term.



Withdrawal of Student

One term's notice of your intention to withdraw a student from the school is required in writing.

Please complete our "withdrawal of enrolment form" located under Parent Resources on our website. Where this is not adhered to, school reserves the right to charge a full term's school fees.

Extraordinary circumstances will be taken into account.

OSHC/Early Learning

The OSHC and Early Learning accounts are billed separately to tuition. The preferred method for payment is using the Xplor App.

Your OSHC & Early Learning accounts **MUST** be kept up to date in order to continue using the Service.
